

#### **About the New Mexico Dream Team**

The New Mexico Dream Team is a statewide network committed to create power for multigenerational, undocumented, LGBTQ+, and mixed status families towards liberation. Through trainings and leadership development, we work to engage our community and allies, in becoming leaders using an intersectional, gender, and racial justice lens—to develop and implement an organizing and advocacy infrastructure for policy change fighting to dismantle systematic oppression.

Our vision is to build people power for the uplifting of the immigrant, queer & communities of people of color. We are committed to empower multigenerational undocumented, queer, and mixed status families for liberation

### **Fellowship Description:**

The NM Dream Team is seeking two highly talented and driven immigrant youth (regardless of immigration status) with a passion for immigrant entrepreneurship to be part of the NM Dream Team's Economic Development Organizing Navigator Program. Organizing Navigators will commit to a 9-month program in which they will engage in training, teaching, and developing and implementing a small business curriculum tailored for a Spanish-language immigrant entrepreneurship. Simultaneously, the fellows will receive leadership development and community organizing training to undertake the organizing and providing leadership development to community members who are business owners.

The fellowship includes a variety of training in different small business curricula, as well as training in related areas of immigration and legal issues, and social and economic justice provided by community partner organizations. The fellows will complete these professional development training opportunities in preparation to facilitate workshops and provide small business consulting to our adult immigrant Spanish-speaking population. The entrepreneurs will then commit to forming part of an immigrant business association that will push for systemic policy change related to economic development in the immigrant community.

After the professional development and shadowing hours are completed, the fellowship includes an apprenticeship period; as a result, the fellows implement their knowledge and develop their own teaching methodology as they have interaction with community entrepreneurs attending the workshops and their situations.

The program then will be followed by a paid Teaching and Organizing Fellowship where the fellows will have the opportunity to facilitate and lead the curriculum developed during the fellowship.

Ideal candidates should have a passion for social justice and immigrant rights, speak and write Spanish fluently and would want to pursue teaching and business consulting.

#### **Stipend:**

- \$ 7,500 in completing of 57.5 training hours plus, extra-curricular working hours dedicated to develop and improve a final Small Business curriculum as a group and completion of Fellowship project.
- Participants must fill out a W9 for tax purposes (using an ITIN or Social Security number)
